#### Rules Of Procedure

"Robert's Rules of Order shall prevail at the Annual Meeting."
Constitution of the West Stafford Church, Art. XII., Sect. B, Item 1h.

#### From "Robert's Rules of Order":

Following the Agenda: "If it is desired to transact business out of its order, it is necessary to pend the rules,

which can be done by a two-thirds vote."

Conducting Business: "Before any subject is open to debate it is necessary, first, that a motion be made by a

member who has obtained the floor; second, that it be seconded; and third, that it be stated

by the moderator."

Debate: "Each member has the right to speak twice on the same question ... but cannot make a

second speech on the same question as long as any member who has not spoken on that question desires the floor. Debate must be limited to the merits of the immediately pending

questions."

The Previous Question: "The form of this motion is, 'I move the previous question!'. As it cannot be debated or

amended, it must be voted on immediately ... the effect of ordering the previous question is to close debate immediately, and to bring the assembly at once to a vote on the

immediately pending question."

General Consent: "Business can be expedited greatly by avoiding the formality of motions and voting in

routine business and on questions of routine importance, the chair assuming general

consent until someone objects."

Voting by Ballot: "Where the by-laws do not require the vote to be by ballot, it can be so ordered by majority

vote, or by general consent."

Acceptance of Reports: "If the report contains only a statement of fact for the information of the assembly, the

reporting member makes no motion its disposal, as there is no necessity for action on the report. But, if any action is taken, the proper motion, which should be made by someone else, is to accept the report, which has the effect of endorsing the report and making the assembly assume responsibility for it. If it is a financial report ... and when the auditing committee reports, this report should be accepted, which carries with it the endorsement of the financial report. If the report contains recommendations ... the proper motion is to

adopt the recommendations."

To Defer Action: (a)Postpone to a Certain Time. If it is desired to defer action upon a question till a

particular time, the proper motion to make is "to postpone it to that time." (b) Lay on the Table. Instead of postponing a question to a particular time, it may be desired to lay it aside temporarily until some other question is disposed of, retaining the privilege of resuming its consideration at any time. The only way to accomplish this is to move that the question "lie

on the table".

Recommended by the Conference Parliamentarian:

Amendments in Writing: Members proposing amendments to motions, resolutions, reports, or recommendations

shall submit the amendments in writing to the clerk at the time the amendment is moved.

The meeting was called to order at 1:09 PM, January 23, 1994 by Moderator Ross Kerr.

As you review the statistics, it has been an interesting and intensely busy year, but a worthwhile year.

Part Two: 5 year Goals - (See elsewhere: "5 Year Goals" Sheet)

-Other church related meetings- 4

- I. Demographic- The physical plant of the church has undergone the most profound change with the new windows and siding installed. We have noticed the increased heating efficiency of the building and many have commented that the church looks great. The physical membership during the year has remained generally constant. We have welcomed several new friends into our fellowship and covenant to include a large confirmation class and other families who have joined. Sadly death and distance has offset this gain, but as is true, some folk have found other parishes and some have moved too far to be active members. This membership adjusting is not atypical and as our agenda notes, we will make a major adjustment later on in this meeting during the general business portion.
- II. Financial- The support of our church and its endeavors remain at a high level and has remained at a high level when compared to prior budgets and outreach. This is most exciting, given the overall economic picture here in CT, particularly in the rural areas such as West Stafford. Our Sunday School's attendance remains constant and we do seem to have people coming to attend from a wider geographic region. Demographically we are well on the way to satisfying our goals and this is extraordinary.

III.Debt- The reimbursement for the siding and roof work is progressing slowly. Now 1 year and 2 months into the fund drive and as of this point of writing we have reimbursed over three quarters of our funds, and the clapboards pledged have been roughly 80% taken. Given my 4 year expectation, I am elated, yet the most challenging part of this goal still lies ahead and this year will bear out this challenge.

## Pastor's Report (Con't)

The hoped-for purchase of neighboring property has not progressed and I suspect it will not future we may need to look at other options. Within that long-range scenario will be the creatic long range planning but this may be an issue for the 1996 year. At present we will need to contrate or king the existing plant efficient in space use and event use.

IV. Ministry- Boards and Committees have remained highly committed and functional, all c capable adjusting to the changing and particular needs of the fellowship. We have remained fully staffed and the nallenge continues for this to continue into the 2nd year. Worship remains punctuated with creativity, variety and ccasional humor. Some days stand out in special note, those being Laity Sunday when again we were honored with three reflections on faith, each superb and each different. The 230th anniversary and Christmas eve remain as highpoints. Baccalaureate and Sunrise Service exemplify new and old traditions which have their place in our community. The prayer chain and Acolytes continue their ministry proudly and I am honored by their efforts to enhance worship and faith. Thanks go to Doris Cramer particularly who has helped keep the Prayer Chain in good order, using her prior experience of other prayer chains. The Bible Study is currently halfway through the year and the winter quarter, deeply immersed in the study of Matthew, and has grown in numbers. Reiterating what I have said before, I expect to put a limit of 10 or so on the class and if need warrants, engage another class at another time. The Youth group, with special kudos to Cindy Lingley's organizing capability, has remained a vibrant fellowship. The tape ministry continues in form and our church's ecumenical involvement within the Stafford region has increased with the addition of this year's Pulpit Exchange and Baccalaureate Service, plus our shared service on Christmas eve.

V. Social - Potluck Suppers remain our high mark. We have had several this year, all phenomenal. Picnics, campfires, softball games and other fun times this year have created superb memories during 1994. Our Scrapbooks tell us of special days and I wish to thank many who made a second set of their photos to share with the church. Events at other churches, ones that are a part of our local group, have also been fun but sadly very minimally attended. OVERALL: As will be shown in other reports more specifically, we have made further progress regarding our goals and tasks. This is quite heartening.

Part Three: Narrative Reflection-

1994 has been a fun year as well as a blessing for Robin and I. Early in last winter it was decided to let our church secretary go and operate without one for a time. This was a critical decision for we remain an active church family and the office remains an active place. I am assuming that in the near future we shall reinstate the position, but in the meanwhile volunteers have taken on office functions and particular tasks like the bulletin and KIT creation. Within that framework, I have done my own correspondence and copying, etc., as programs and church events progress. Special thanks to Robin Wadsworth whose wrestling matches with the church computer begets nice looking bulletins, and the Tripolis who have undertaken to create, copy and collate editions of KIT. Special thanks here to Ken May on his numerous helps when called regarding computer antics, mishaps, mysteries and general electronic mayhem. This has been a year of heavy demands personally as we have purchased a home in Stafford. Again thanks to the crowd-crew who helped that Saturday. Jack Richens commands particular thanks, even though I did not believe him that all that furniture and books could be moved in such a short time. I was wrong, Jack. This move now releases the parsonage to be sold in 1995 to create income and lower liabilities. This will go some distance to solidify our cash flow and equity picture.

1994 was punctuated with our 230th Anniversary and the publishing of our church <u>History</u>. This year long research endeavor caps off the celebration of Stafford's longest continual church family. The Single day event was a buffet for many tastes with good weather and fall colors, punctuated with picnics, potluck suppers, worship, historical and archival displays, lectures and costumes remembering the latter 1700's. At present the <u>History</u> is 3/4 sold from the first printing. Only a week later the Holly Bazaar geared up and was a feast of unique gifts, sales and foods. That B.T.S. cake is a must for future events! A lot of work went into the day beginning a year before and many holidays were made more special because of the gifts shared. The "greening" potluck luncheon was a fun time. We were especially blessed by the serenade of carols by Mildred Calchera during the worktime. (Yes, we did fix the creche figure Joseph's head.) Again we concluded the festive celebration with three Christmas eve services, all wonderful, and worship together on Christmas day. I was honored at the high level of attendance at each service Christmas eve as

well as on Christmas Day. As was the case in years past, our choir remained in superb form and its musical offerings, not just on Christmas eve but year round, continue to be superlative. (Bravo, Jim Tripoli).

This year some concentration was given to the Church Educational process and structure with some solid results. The children involved seemed to be strengthening their knowledge and connection with Scripture with some success at internalizing. We have been experimenting with a chapel gathering once a month with some success and this will be reviewed in early 1995. Administratively I feel the staff feel better supported, the students learn more and learn better and the program seems more streamlined. As is normally the case, upgrading any program does take much additional energy. Robin Davis and Linda Sprague are to be commended for proactive organization and Sue Leavitt thanked for leadership in Chapel. Our church library has again been substantially increased and (thanks to John Leavitt and others) is one of the better church libraries in the Association.

Administratively, 1994 has been challenging. The office has been reorganized functionally in lieu of secretarial help. I feel operations have continued efficiently and committee members have responded to the situations and needs superbly. The computer remains a central tool (although humbling at times!).

It is a constant that our membership remains deeply involved in the events and decisions made in town regarding the elderly, taxes, schools and other scenarios. These connections and arena are also our fertile grounds for outreach and a deep commitment to help locally and through the wider church is a legacy we embrace. It obviously behooves us to continue this involvement, outreach and fellowship.

1995 will be a challenging year for Second Congregational Church and I need to allude to some of these challenges to our covenant and fellowship. The first challenge is to be involved in events beyond worship on Sundays. Some of the flavor and fun of our church family is also shared beyond worship. I realize families must make choices regarding events and scheduling. The church counts upon its fellowship being an important part of its members' lives and overall, our church needs to be more than an appointment. The second challenge is directed more at the men in our church than at the women. Church is important for men as well and children need to reinforce the fact that fathers can be faithful too. I would hope to see more families together in worship as well as at events during the year. A third issue/challenge is publicity. First continued thanks are given to the Glennisters for publicizing church events. Still we have a challenge to connect with markets, participants and buyers beyond the West Stafford region. Within an 8 mile radius are 3 communities rarely impacted by publicity unless the chair of an event for the most part puts out fliers or posters, this usually less than 2 weeks prior to the event. The more successful our fund-raisers are, the less support needed from pledges and investments and this publicity has a roll-over effect upon evangelism, membership and other parts of church life. Since our church family is drawn from such a wide region we could add 25-50% to fundraising revenues if our marketing was enhanced. Last but not least, It is proper to begin to train assistants. A final challenge this year is for those in positions of leadership or coordination solicit one other person in that group or from the church to be gleaned to take on leadership. During the year spend some time teaching him or her the ropes. This challenge goes far to give understanding to coordinate currently successful events and their administration, plus creates a leadership core in event of emergency. It also insures continuing balance between parochialism and modernism, as well as creates a resource of ideas.

That being said, I do applaud each and all of you who have made this a banner year. Your hard work, care and ideas continue to be a bonanza. I count on the creativity and steadfastness of our church family. I count upon each of you being a part of the fellowship and do miss you when absent. I will continue to challenge you to be faithful to God and responsible in life. I will promise to give you the best I have to offer within the limits of time and energy, and solicit your forgiveness when I have erred. Second Church is, and remains, within my prayers.

Second Congregational Church continues to be that place where people can dream, practice, worship, heal and activate both life and faith. May God walk with us and within us this new year.

#### **Trustees**

The Board of Trustees met in ten regularly scheduled meetings and several impromptu ones to oversee the financial and physical needs of Second Congregational Church of Stafford. The major issue dealt with in 1994 was the Siding and Window Replacement project for the Church Building. Mark Hervieux, the carpenter who reroofed the Church in 1993, was chosen to side the Church. At a Church Meeting, it was voted to replace the windows with insulated, tilt-in models while the siding was in progress. Due to a variety of minor repairs needed during the siding work, and due to a very active wasp population in the fall, the belfry portion of the building will be completed in the Spring of 1995.

The columns in front of the Church will need to be painted in the Spring as well. Many thanks to Kim Grotheer for painting the sign for our fund-raising for this project.

In matters more mundane, two successful Work Days were carried out, taking care of yard work and major cleaning of the Sanctuary. The new windows removed the need for storm windows installation and removal, making Work Day a more pleasant experience for all.

The Trustees have formed an ad hoc committee to advise them on the investing of our Church moneys. After much deliberation, it was decided to invest our restricted-fund moneys in Five- and Ten-Year Treasury Notes to get the highest return in a low-risk, insured setting.

We thank Robin Wadsworth for volunteering to fill the vacancy left by the death of Bob Anderson. His advice and expertise has been missed since his passing. Thanks also go out to Fred Borman, secretary of the Trustees, for his diligence in note-taking and correspondence.

As always, the Trustees owe a great debt of gratitude to our Treasurer, John Leavitt, for all his guidance. His vigilance in matters fiscal have been greatly appreciated by this Board. We would also like to thank all the fundraisers of this Church body. Events such as the Holly Bazaar, the Summer Flea Market, and the Spring and Fall Tag, Rummage, and Bake Sales help make our job of balancing the finances much easier.
